Health systems in developing countries:

- 50-80% of resources are in urban, however lrg number of people present to other regional hosp.

- Use the 5 Moments- WHO for HH
- <40% compliance for HH
- ABHR is more commonly used rather than soap and water
- WHO has a formulation for ABHR, it is made by the facility

 - i. Sharon- Is anyone doing environmental cleaning audits? ES to hold the responsibility. How can IPAC support?
 - ii. Margaret- Good experience with Glow Germ. Has to pick the right surface to put the liquid on (Q-tip application). Recommendation: non-porous surface. Good to identify frequently touched surfaces. IPAC does the auditing, looking to train the supervisors to continue with the audits. Audit is done at random with 24hr for the cleaning to be preformed. Audit and monitoring to be done together. On going monitoring to check sustainability for performance. IPAC to do the Glow Germ.
 - iii. Denise- Glow Germ on high tough surface. Manager of ES needs to take ownership. Door knobs, light switches, bathroom spaces, POC, NOT ON RAILINGS. Can be used on Shared Equipment. Compliance increased after doing these audits. This does not replace the need of direct observation of the ES process... clean to dirty, etc.
 - iv. Janessa/Teri- ATP monitoring. Measures the bio-burden of a surface. Shows how well the cleaning was preformed.
