

- ESBL is a significant Ontario problem
  - Klebsiella ESBL- HAI

  - 86% resistant to Cipro
- No good drug to treat E.coli ESBL
- She talked about ABX use in asymp bacteriurea
- CPE is on the rise

- Best bang for your \$:

- HH programs
  - ABHR for personal staff (e.g., pocket) as well as wall dispensers
  - Intervention
  - Performance feedback

- Discussed stopping mid stream urine cultures if in hosp >48hrs OR having the results not sent back to the unit... they would have to call if they really wanted to know.
- She is stopping urine cultures on the surgical floors. She would like to extend this to the medical floors.
- Q&A: LTC rep felt that if they practice ASP, but then resident health declines, goes to acute care facility, then receives ABX for ?UTI. Needs to be a partnership with ASP between LTC and acute
